# Ministry of Education Huayu Enrichment Scholarship (HES) Foreign Student Information for UK Applicants 2024 - 2025

#### 1. Purpose

Established by the Ministry of Education, Republic of China (Taiwan) (the MoE) to encourage international students (Mainland China, Hong Kong, Macao students are not eligible) to undertake Huayu (Mandarin) courses in Taiwan in order to provide them with opportunities to study authentic Mandarin, to increase their understanding of Taiwanese culture and society and to promote mutual understanding and interactions between Taiwan and the international community.

#### 2. Award Value

A monthly stipend of 25,000 NTD (equivalent to approx. £660).

#### 3. Duration

Huayu Enrichment Scholarships may last three months, six months or nine months, although a very limited number of nine-month scholarships will be awarded. Recipients of the nine-month scholarship must submit a Band B or higher certificate or transcript of a Test of Chinese as a Foreign Language (TOCFL) prior or during their time studying in Taiwan.

- The *nine-month scholarship* may run either from **a**) September 1<sup>st</sup> 2024 to May 31<sup>st</sup> 2025; or **b**) from December 1<sup>st</sup> 2024 to August 31<sup>st</sup> 2025.
- The *six-month scholarship* offers three options within the academic year: **a)** September 1<sup>st</sup> 2024 to February 28<sup>th</sup> 2025 **b)** December 1<sup>st</sup> 2024 to May 31<sup>st</sup> 2025 or **c)** March 1<sup>st</sup> 2025 to August 31<sup>st</sup> 2025.
- The *three-month scholarship* can cover one of four terms within the university year: **a**) September 1st to November 30th 2024 (autumn term); **b**) December 1st 2024 to February 28th 2025 (winter term); **c**) March 1st to May 31st 2025 (spring term); or **d**) June 1st to August 31st 2025 (summer term).

Please refer to the scholarship application form for a full and clear list of all available options.

If recipients fail to come to Taiwan for enrolment at the designated time, they will forfeit their right to retain their scholarships. Scholarship funding will become effective on the date of the recipient's enrolment. Scholarship funding will end on the month of the expiration of the scholarship or if the scholarship is revoked.

Recipients are expected to remain at their language courses until the very end of the designated study period. It would not be acceptable to miss the final weeks (in order to travel, take up employment, etc.) and to do so will negatively affect the quota of scholarships allocated to UK applicants in future years. Please note that the first stipend will not be transferred to scholarship recipients until 4-6 weeks of classes have taken place and attendance levels have been confirmed. In addition to general living costs, various fees and deposits may need to be paid during this early stage; scholarship students should therefore prepare sufficient funds to cover initial expenses. As costs can vary depending on the area, seeking advice on this point from the language centre prior to arrival is recommended.

#### 4. Eligibility

International applicants above the age of 18, who possess A-Levels (or equivalent qualifications) or above, an excellent academic record and are of good moral character are eligible. Candidates to whom one of the following criteria apply are ineligible for the scholarship.

- a. Overseas Chinese students and nationals of the R.O.C.
- b. Those currently registered as a student at a Mandarin Language Centre or who have sought a degree from a university or college in Taiwan.
- c. Those who have previously received a HES or a Taiwan Scholarship.
- d. Those who will be an exchange student to Taiwan during the scholarship period.
- e. Those currently receiving financial benefits from the Taiwan government or other educational institutions.
- f. Those who are not UK nationals.

(Non-UK citizens may be able to apply for the scholarship via the Taipei Representative Office in their country of citizenship. Those who are unsure how to locate the appropriate office should contact the Scholarships Office: <a href="mailto:taiwanscholarship@mail.moe.gov.tw">taiwanscholarship@mail.moe.gov.tw</a>.)

#### 5. Application

Applicants are required to electronically submit their application via the following Google Form: <a href="https://forms.gle/PDyT2VhytcDy776w7">https://forms.gle/PDyT2VhytcDy776w7</a> before the announced deadline (17.00 BST, Sunday 31st March, 2024). They are required to submit the following documents as part of their application:

- a. An application form (to be found on the BACS website).
- b. A scanned copy of their UK passport.
- c. Scanned copies of the certificates and transcripts of their highest academic qualification (i.e. degree certificate or A-Level certificates). Current university students who have not yet graduated should include a copy of their most recent transcript of study.
- d. Proof of application to a recognised Taiwanese Language Centre (e.g. valid admission letter or e- mail from the language center's admissions department acknowledging receipt of application).

e. <u>Two</u> letters of reference (which must be submitted by referees directly to BACS, on the reference form provided by BACS on their website, to the e-mail address bacs.huayuscholarship@gmail.com).

Please note only two references will be accepted and any additional letters of reference submitted will not be considered. The applicant should check with their referees that BACS has acknowledged receipt.

Applicants must already have submitted an application to their chosen language centre for the appropriate semester before applying for the Huayu Enrichment Scholarship.

The entire scholarship application, including the supporting documents listed above, (but excluding reference letters that must be sent by the referees to bacs.huayuscholarship@gmail.com), must be submitted through a Google form (<a href="https://forms.gle/PDyT2VhytcDy776w7">https://forms.gle/PDyT2VhytcDy776w7</a>) whose link will also be provided on the BACS website. BACS will send an acknowledgement e-mail to confirm receipt of every application form and reference submitted. Receipt of references will be confirmed directly with the referees rather than the applicants. <a href="https://forms.gle/PDyT2VhytcDy776w7">It is the applicant's responsibility to ensure that their complete application (including both references) has been received by BACS.</a> If an applicant and/or their referee does not receive an acknowledgement e-mail, they should contact BACS.

If, upon confirmation through BACS, it is determined that a person's application submitted via the Google form has not been received, they have the option to re-submit the application via email at bacs.huayuscholarship@gmail.com.

It is not possible to rectify issues relating to incomplete applications after the deadline has passed, even if technological factors were at fault.

#### **6. Selection Procedure**

- a. This will be carried out as stated by the British Association for Chinese Studies (BACS) and the Education Division, Taipei Representative Office in the UK (TRO). All submitted documents will be processed and reviewed.
- b. Candidates short-listed for a full nine-month scholarship may be asked to participate in an interview arranged by the Education Division, likely towards the end of April.
- c. When a successful candidate has waived their right to a scholarship before arriving in Taiwan, their position will be filled by the next reserve candidate.
- d. Preference will be given to scholarships of shorter duration and to applicants not already living in Taiwan in order to enable a greater number of candidates to benefit from the opportunity to study in Taiwan.

#### 7. Terms and conditions: Recipient

- a. The recipient should study at a <u>registered Mandarin Language Centre approved by the MOE</u> (please refer to the following list: https://english.moe.gov.tw/cp-23-24206-13c8a-1.html).
- b. Applications to language centres should be made according to the regulations of the centre.

- Scholarship recipients will later be asked to forward a copy of their admission letter to the Education Division for confirmation. Recipients who fail to do so may be disqualified from the process.
- c. The recipient should undertake at least 15 hours of language courses each week. This does not include cultural visits, speeches and other self-learning curricula or activities.
- d. Recipients are not allowed to apply for a transfer to a different language centre.
- e. If the recipient concurrently accepts scholarships from other sources, they will lose their place on the scholarship programme and will have to return the funds granted for those months they received multiple scholarships.
- f. The termination and cancellation of a scholarship is based on regulations specified by each individual Mandarin Language Centre and the HES guidelines set by the Ministry of Education, Taiwan. Mandarin Language Centres have the right to terminate or revoke a scholarship if the recipient's academic performance, moral character or attendance record is not up to standard.
- g. Recipients of scholarships longer than six months are obligated to join the National Health Insurance Programme. Insurance fees can be deducted by the Mandarin Language Centres from the monthly stipend before it is paid to recipients. Recipients should ensure that they have purchased appropriate insurance to cover the full period, particularly the first six months before joining the National Health Insurance Programme.
- h. The scholarship will be suspended (one month's stipend per instance) in the following cases:
  - If a student is absent from twelve hours or more of classes in one month;
  - If the grade point average of a scholarship recipient falls below 80 points (out of 100) for one term of study;
  - If a recipient of the nine-month scholarship does not participate in the Test of Chinese as a Foreign Language (TOCFL) Band B or higher and fails to submit a valid TOCFL certificate, it will cost the recipient a month's grant subsidy. No exemptions can be permitted for late registrations. Recipients should pay for the TOCFL themselves. The latest date for submitting a valid TOCFL certificate or transcripts is one month prior to the completion of their study term. Scholarship recipients who had submitted a recent TOCFL certificate (for Band B or higher) at the time of applying for the scholarship are not required to sit the test again.
- i. The scholarship will be revoked in the following cases:
  - If the grade point average of a scholarship recipient falls below 80 points (out of 100) over two consecutive terms;
  - If a scholarship recipient is missing a final achievement score for any semester (quarter) (except in the event of serious illness or injury);
  - If a scholarship recipient violates Taiwanese laws;
  - If a scholarship recipient violates any rules set by their language centre / university.
